

**MUSIC CHOICE X ARMSTRONG “DIERKS BENTLEY TICKETS”  
SWEEPSTAKES OFFICIAL RULES**

**OPEN ONLY TO LEGAL U.S. RESIDENTS RESIDING WITHIN 100 MILE RADIUS OF  
BURGETTSTOWN, PENNSYLVANIA. VOID WHERE PROHIBITED.**

3. **ELIGIBILITY:** From the official time and date of the start of the Sweepstakes Period through the final date of prize fulfillment, you must be a lawful permanent U.S. citizen and resident residing within 100 mile radius of Burgettstown, PA the (“**Eligible Area**”).
