Yeti Cooler Summer Giveaway Official Rules & Regulations

1) Sponsor

Armstrong® is the sponsor of this promotion (the “Sponsor”).

2) How to Enter:

- a. In-Person Entry: Individuals may enter the contest at any Armstrong® event this summer by filling out an official entry form and placing it into the designated cooler at the event.
- b. Entry Limits: Limit one (1) entry per individual per event attended. No mechanically reproduced entries permitted.
- c. All entries become the property of the Sponsor and will not be returned or acknowledged.
- d. Sponsor assumes no responsibility for incomplete, late, lost, or illegible entries, or for entries distorted, damaged, or delayed for any reason.
- e. NO PURCHASE NECESSARY. Entry is free and open to the public, subject to eligibility as outlined below.

3) Eligibility:

- a. Must be a U.S. resident, 18 years of age or older, residing within the geographic area served by Armstrong® (including, but not limited to, Kentucky, Maryland, New York, Ohio, Pennsylvania, and West Virginia).
- b. You do not have to be an Armstrong customer to enter or to win.
- c. Entrants must live within Armstrong’s service footprint and must be able to make arrangements to pick up their cooler at a local Armstrong office if selected as the winner.
- d. Winner agrees to have a photo taken at the time of prize pick-up, which may be used by Armstrong for marketing purposes, including website, social media, and advertising.
- e. Employees and family members (as defined: spouse, child, parent, grandparent, sibling—including step/household members) of Sponsor, its subsidiaries, affiliates, advertising and promotional agencies, or legal advisors are not eligible.

4) Drawing & Winning:

- a. Odds of winning are dependent upon the number of eligible entries received at each participating office.
- b. A winner will be selected by random drawing from all eligible entries at each Armstrong office at the conclusion of the promotion period which is September 7th.
- c. Winner will be contacted by phone and/or email within three (3) business days of

drawing.

d. If the winner cannot be contacted within three (3) business days, or is unable/unwilling to comply with prize requirements (pick up, photo), an alternate winner may be chosen by random drawing from remaining eligible entries.

e. Prize: One (1) Yeti cooler per office

f. No substitution, transfer, or cash redemption of prize, except as expressly determined by Sponsor in the event of prize unavailability.

g. All federal, state, and local taxes are solely the responsibility of the winner.

h. Winner may be required to provide a valid form of identification and sign a liability/publicity release prior to receipt of the prize. Acceptance of the prize constitutes permission for Armstrong to use winner's name, photo, and likeness for promotional purposes without additional compensation unless prohibited by law.

e. Contest may be canceled, suspended, or modified at any time at Sponsor's sole discretion, including, but not limited to, if fraud, technical failure, or any other factor impairs the integrity of the contest as determined by Sponsor.

f. Sponsor reserves the right to disqualify or prohibit participation of any individual if fraud or tampering is suspected or if the individual fails to comply with all contest rules.

g. Winner assumes all liability and agrees to hold Sponsor, affiliates, and their officers, employees, and agents harmless for any injury, loss, or damage caused by participation or acceptance of any prize.
