

Duck Dash for the Holidays Contest Official Rules & Regulations

1. **Sponsor:** The Duck Dash for the Holidays Contest is sponsored by Armstrong.
2. **How to Enter:**
 - a. Participants can enter the contest by collecting all four themed rubber ducks during the designated scavenger hunt months.
 - b. To receive a rubber duck for each month, participants must show proof of membership at their local office.
 - c. Participants must bring all collected ducks to the local office in January to be eligible for the grand prize.
 - e. NO PURCHASE NECESSARY.
3. **Eligibility:**
 - a. Must be a U.S. citizen, 18 years of age or older, residing within the geographical area served by Armstrong.
 - b. Employees of Armstrong and their household members are not eligible to participate.

 - **January:** Bring all three holiday ducks back to your local office, show proof of membership, and receive the official Zoom Zone duck, which enters you into the grand prize drawing for a \$1,000 gift card.
6. **Other Terms:**
 - a. All federal, state, and local laws and regulations apply.
