1) How to Enter:

- b. Color the page using any method of choice – digitally (e.g., iPad) or traditionally (e.g., crayons, markers, paint)
- c. Submit your completed artwork by uploading it to The Zoom Zone
- d. NO PURCHASE NECESSARY. Mailed entries may be sent to:

Entries must include name, address, and daytime phone number. All mailed entries must be postmarked no later than November 30, 2025.

2) Eligibility:

- a. Open to legal U.S. residents who are 18 years of age or older and reside within Armstrong's service areas in Kentucky, Maryland, New York, Ohio, Pennsylvania, and West Virginia.
- b. Entries on behalf of minors must be submitted by a parent or legal guardian who **is at least 18 years of age**. In the event that a minor's entry is selected as the grand prize winner, the prize must be claimed by the parent or legal guardian.
- c. Employees, contractors, affiliates, and immediate family or household members of Armstrong or its promotional partners are not eligible to participate.
- d. All participants must be active Armstrong customers in good standing (no outstanding balance).
- e. **Participants may submit multiple entries; however, only one (1) entry per person will be counted toward winner selection.** Additional submissions will not increase chances of winning and will be disregarded during judging.
